This is enough seed to grow over 18 million fresh vegetable servings, containing nutrients that grow health minds and bodies, and change the lives of gardeners worldwide.

These shipments, combined with appropriate local training, tools, and support, resulted in gardens benefiting more than 77,305 people. Over 29,600 people attended garden-related trainings, improving gardening practices and moving communities toward self-reliance. 98% of program managers said nutrition and income improved for their beneficiary communities and families as a result of the program. For families in more than 24 countries impacted by disaster, armed conflict, chronic
