This is enough seed to grow over 9 million fresh vegetable servings, containing nutrients that grow health minds and bodies, and change the lives of gardeners worldwide.

These shipments, combined with appropriate local training, tools, and support, resulted in gardens benefiting more than 131,000 people. 97% of program managers said nutrition and income improved for their beneficiary communities and families as a result of the program. For families in more than 22 countries impacted by disaster, armed conflict, chronic stress and poverty, these gardens provide life-saving nutrition and income.
